The “system” from the families’ perspective

- ▶ The Aha! Moment
- ▶ Social issue with legal aspects, not the reverse
- ▶ Required: more than the expertise of lawyers and judges



Kahane and Complex Problems



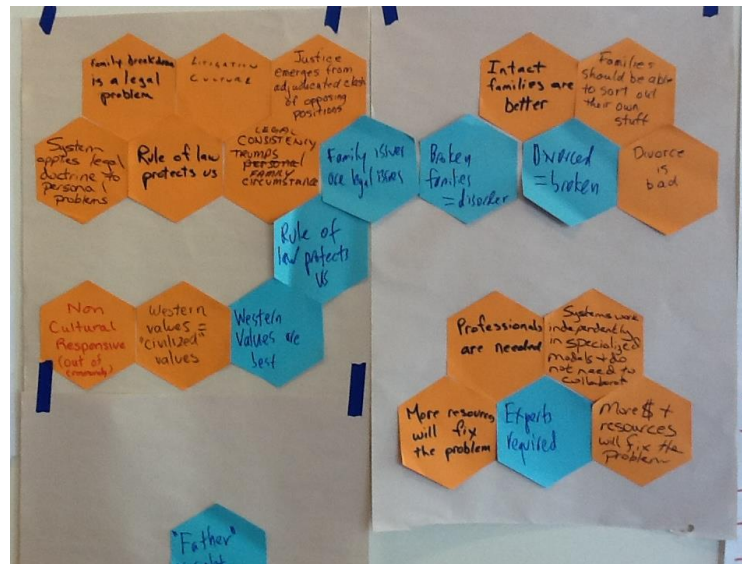
- ▶ Making the family justice system work for families is a complex, not complicated, problem

- ▶ The three basic characteristics:
 1. Experimental
 2. Participatory
 3. Systemic

Founding Meeting

- ▶ June 1 and 2, 2014 Vancouver
- ▶ Funded by BC Law Foundation
- ▶ 20 invited participants - broader than usual base
- ▶ Identification of Purpose, Strategy, Stakeholder identification

What is Developmental Evaluation?

- ▶ An approach not a method
- ▶ Builds on traditional evaluation methods
- ▶ Focuses on innovation and strategic learning
- ▶ For dynamic and uncertain environments
- ▶ When outcomes not known in advance

Baseline Report

- ▶ To understand trajectory of emerging Lab
- ▶ Interviewed Lab team, initiative leads
- ▶ Looked at Lab's theory of change and asked probing questions
- ▶ Held up mirror on current and possible activities



Relationship to Justice System Actors?

Justice system analogous to an organization that needs to adapt to survive or thrive

Two parallel systems

- ▶ Operating - traditional process that handle operational needs
- ▶ Strategy network - innovative, mobilizes volunteers, continually formulates ideas

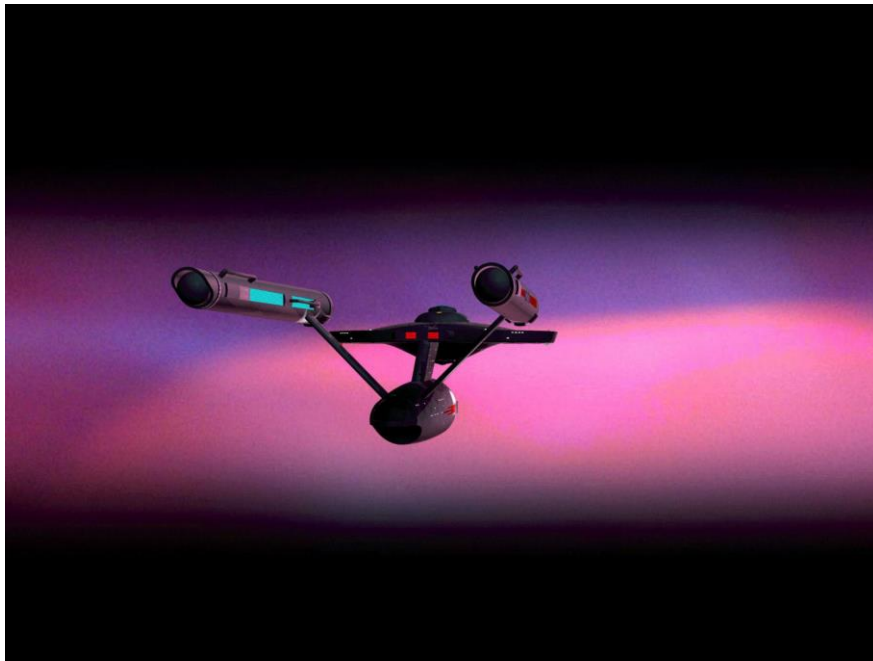
